AS 2014 CAME TO A CLOSE, one of the larger development projects that our neighborhood had seen in a while was approved by City Council. The Terrace Hotel will be a 102 room luxury hotel, developed by Clark Lyda, run by Liz Lambert's Bunkhouse Group, and is located at 110 Academy Drive between Music Lane and Hotel St. Cecilia. The current property is a group of aging offices and apartments that were once part of the historic Terrace Motor Hotel which stretched across Academy and onto the property that is now State House Apartments.

Lyda and his team approached SRCC in early 2014 with preliminary design plans because they needed zoning and neighborhood plan

Permits for 2015 SXSW Events

EVENT PERMITS ARE an ongoing concern for SRCC residents, but especially every year during SXSW. Officials with the City of Austin's Music and Entertainment Division recently both met with SRCC leadership and spoke at the February SRCC general meeting, to let us know the measures they are taking to get the number of event permits under control.

This year, the goal is to reduce multi-day event permits by 20-25% citywide during SXSW. Within the SOCO corridor itself, they are reducing these permits from nine in 2014 to seven in 2015. There were 12 multi-day event permits issued in 2013 for this area. While multi-day event permits are temporary and are good for up to four days of an event, outdoor music venue permits (OMV) are year-round. Currently six businesses on SOCO that have OMVs, and they were factored

Norwood Park Project: Moving Along Nicely and More!

IN DECEMBER, THE NORWOOD HOUSE was picked up and moved for the third time in its history—this time only temporarily to make way for construction of a new foundation. The piers are drilled, the grade beam is now done, and the house will soon be back in its correct historical location, with new foundation walls completed. By April, when Phase 1 of the Norwood Project is done, the structure will have been permanently stabilized and will have a new subfloor and roof decking. This stabilization will allow the house to sit tight while Norwood Park Foundation (NPF) moves forward with planning and fundraising for the remainder of the project.

We will soon be using a grant from SRCC to restore the historic view of downtown and uncovers formal garden structures by removing dead and invasive trees. Another grant will provide care for our heritage oaks. We appreciate the support of SRCC as we continue moving forward.

IN DECEMBER 2014 THE CITY OF AUSTIN and Austin Arts Commission approved a plan for "The Larry Monroe Forever Bridge," a tribute mosaic for the late Austin DJ, Larry Monroe. The mosaic will be on the small bridge on Eastside Drive, just north of Monroe Street between Big Stacy and Little Stacy Parks, near where Larry once lived.

Larry was a beloved musicologist who hosted iconic radio programs on KUT-FM for 29 years and KDRP Sun Radio for three. His popular programs include "Blue Monday," "Phil Music" and "Texas Radio Live," the last still ongoing at Güero's Oak Garden every Wednesday night from 6-8 pm. While Larry was knowledgeable about many genres of music, his specialty was Austin and Texas songwriters, and he never stopped promoting them—Larry is one of the reasons Austin is known as the Live Music Capital of the World.

Mosaic artist Stefanie Distefano and I will head up a team of volunteers who will create the tiles for this community-based mosaic project. changes in order to make their concept a reality. Through most of 2014, a team of representatives from SRCC and the GSRC Neighborhood Plan Contact Team worked closely with the developer to consider their proposal. The property is surrounded by commercial use (including another hotel), and thus development was determined to be an appropriate use for that part of the neighborhood. However, the project still required amendments to the Fairview Park Neighborhood Conservation and Combining District, and the Neighborhood Plan's Future Land Use Map, as well as an underlying zoning change. SRCC and the GSRC Neighborhood Plan Contact Team do not take such changes lightly and worked very hard to come up with a set of restrictions and concessions that benefited the neighborhood in exchange for the zoning and plan changes needed. In the end, Lyda and his team agreed to have per-building height restrictions, event size limitations, no outdoor amplified sound, access restricted to Music Lane, free valet parking, and the construction of a 200 space parking garage among many other things. These were set into a Private Restrictive Covenant and reviewed and approved by a lawyer of our choice. City Council approved the changes on December 11th.

This process is an excellent example of how a developer can work pro-actively with SRCC to produce an excellent product with neighborhood support. We look forward to the Terrace Hotel opening and hope that other developers will work with us in a similar manner in the future.

As 2015 begins, another project returns to the spotlight. Reagan Outdoor Advertising owns property on the

Northwest corner of Woodland and I-35 and engaged with SRCC a few of years ago to acquire a zoning change to allow them to develop the property into a commercial self-storage facility. To obtain the zoning, Reagan agreed to restrict the use of the site to only self-storage (or anything that was allowed under the original office zoning) with restrictions on physical qualities of the building and hours of operations, among many other things. The goal was to make the structure appear and behave as much like an office building as possible. This resulted in a Private Restrictive Covenant between Reagan and SRCC that very narrowly defines what this development can act like.

The site has remained undeveloped—until now. SRCC received notice in December that the Reagan has submitted a site plan for administrative approval—which means they do not require any additional variances or waivers to get it approved. SRCC is following this process closely and has requested to meet with the developer to ensure that the site plan will adhere to the restrictions that were stipulated in our Restrictive Covenant. One of the difficulties with Private Restrictive Covenants is that the City does not get involved in enforcing them—SRCC must ensure that the site plan that the developer has submitted adheres to the restrictions in our agreement. That said, it is in the developer's interests to make sure that they are not violating the agreement in any way—for SRCC can file an injunction that will stop all development or operation of the site until it can be determined that they are in compliance. We will continue to update you on this development. ☘

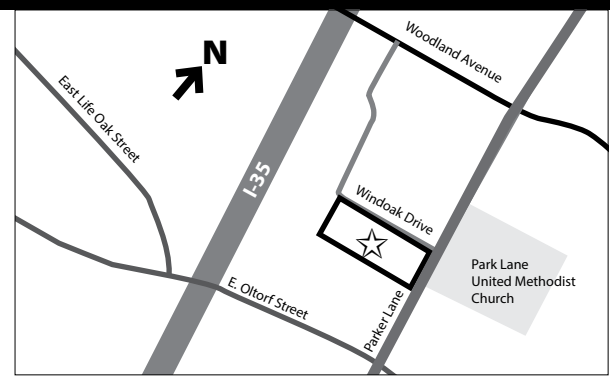

Heritage Oaks Park Gets Grant from Austin Parks Foundation

SRCC HAS RECEIVED A GRANT from the Austin Parks Foundation that will be used to improve our neighborhood's new 'pocket park', Heritage Oaks Park. The park is located in SRCC Area 7 at the corner of Parker Lane and Windoak Drive. The grant will fund installation of picnic tables, trash receptacles, benches, a trail loop and ramp access to meet ADA requirements. Austin Parks Foundation is a partner in the project and will provide, in addition to the funds, many resources including support of workdays in the park, signage and guidance in successful park development. The park is distinguished by four magnificent heritage oaks located on a central high point. The west end slopes gently to a riparian growth zone and pond. Users of the park can enjoy the generous shade, the views from key vantage points, and two open areas. Dogs on leash are welcomed.

Acronym Alert: SRCC; EROC. See footnote at end of article.

You may remember the property at 2100 Parker Lane as a private residence notable for the large colonial style house. The transformation from a residence to a city park was an 8-year effort by neighborhood residents active in the area planning teams** and SRCC members, notably Toni House, Fred Krebs, Gayle Goff, Linda Land and Helen Fleming. In 2003, EROC and SRCC recommended that the property be considered for purchase by the City of Austin as a park. At that time, it was for sale for less than \$400,000. Neither the City's Planning and Zoning Department nor PARD supported the combined neighborhoods' recommendation. Undaunted, the organizations continued to make the case that this is a densely populated area of the City that lacks sufficient parkland and the best use of this property was as a park.

Several years later, the first application for an up-zoning of the 2100 Parker Lane property to a higher density use was filed. The highly contested up-zoning was granted in April 2006, but due to the combined efforts of SRCC, Pleasant Valley and Parker Lane residents, the City imposed a public restrictive covenant prohibiting the removal

of all trees on the property having a circumference of 60 inches or more, measured four and one-half feet above natural grade.

During the summer of 2006, the property owner filed an application to up-zone the adjoining lots where the pond is located (1701 and 1703 Windoak Drive). Prior to the case being heard by City Council, SRCC was successful in convincing Mike Lyday, a Senior Environmental Scientist of the City's Watershed Protection and Development Review Department, to perform a wetland assessment of the property. Mr. Lyday designated the area as a wetland critical environmental feature (CEF). Although highly contested, the up-zoning was granted, however the CEF designation provided some additional protection for the property.

In the summer of 2010, the property owner's agent contacted Fred Krebs, SRCC Area 7 Coordinator, regarding whether SRCC would support the possible acquisition by PARD of the 2100 Parker Lane, 1701 and 1703 Windoak Lane properties for a pocket park. SRCC, Parker Lane and Pleasant Valley residents had never stopped lobbying for the purchase of this property as a park, and quickly stepped up these efforts. To express the neighborhood's support for the purchase, emails were sent and meetings held with PARD staff, Parks Board members, Neighborhood Planning staff and City Council members. When negotiations between PARD and the property owner stalled, more emails were submitted and SRCC members met with Council Members Laura Morrison and Chris Riley in an attempt to get things moving again.

Finally, in December 2011, PARD and the property owner reached agreement on the purchase price and the planning began in earnest. An early participant in the Adopt-A-Park program, the neighborhood formed Friends of Parker Lane Park. To commemorate the majestic heritage oaks, the property was named Heritage Oaks Park in 2012. Helen Fleming recruited neighbors and organized workdays and projects such as removing litter, preparing soil for planting wildflowers, and adding mulch. Now neighbors will be working with Urban Forestry to plant native slow growth hardwood trees. It is recognized that certain areas, especially the pond, should remain wildlife

habitats. The pond is spring fed and home to a healthy population of mosquito-eating fish. The pond area also provides migratory shelter for egrets, occasional foxes and other wildlife. Neighbors will work with Grow Zone coordinators to develop a long-term riparian plan that will conserve the delicate ecological balance. SRCC is grateful to the Austin Parks Foundation for awarding this generous grant and being a partner with the neighborhood in improving and conserving Heritage Oaks Park. ☼

into the overall impact of events on the neighborhood during SXSW. City officials have committed to only approving seven multi-day event permits in 2015 along the SOCO corridor between Riverside and Ben White. (See chart below.)

Although permit application notices are automatically

sent to residences and neighborhood associations within 600 feet of the property seeking an event permit, **these are only alerts**. They do not mean that the applications have been approved nor that they will be approved at the stated decibel limit. The stated decibel limit is a default of the highest limit that can be granted.

This year the City is leasing three mobile sound monitoring systems that can be placed in areas to measure the decibels. They plan on placing one to two of them in the SOCO area for one to two days to capture sound levels during SXSW. (These can be placed in problem areas at any other time as well.) They can revise permits and place further restrictions immediately if the systems show that venues are not complying with their permits. SOCO, East 5th and 6th Streets are identified as their biggest areas of concern during SXSW 2015 in regards to event permits and sound. They'll be creating a citywide sound map this year to track sound problem areas.

Other positive steps include Austin Police Department's addition of a new, dedicated enforcement officer to assist the Music and Entertainment Division in enforcing event permit violations. Officials will now be able to monitor sound levels from their command station during SXSW and notify the enforcement officer of violations in progress. Also, some event permit holders will be required to reset their speakers so they face at an angle towards the ground rather than straight out. Hotel San Jose will be one of those venues.

One final improvement this year will be a significant TABC presence during SXSW 2015. Although alcohol regulation does not fall under the Music and Entertainment Division's purview, this additional safety measure came about because of the post-SXSW report last year. ☼

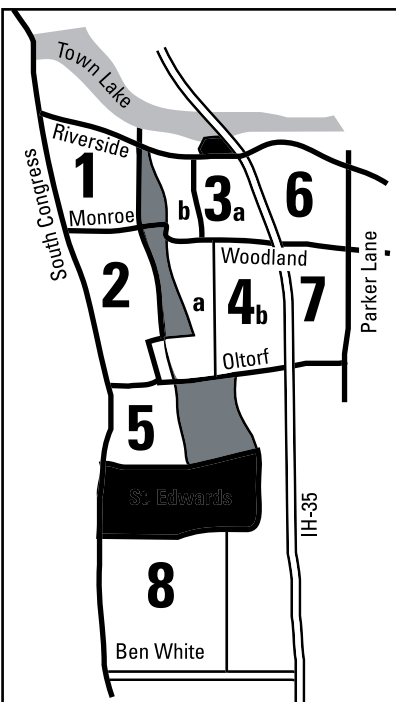
