## Ad Hoc Bylaws Update

The Ad Hoc Bylaws Update Committee has been meeting monthly since January 2016. ## Torchy's Tacos Alcohol Waiver

On Thursday, May 19th, the Torchy's Tacos alcohol beverage waiver was scheduled to be heard by the Austin City Council. This was not the first time this matter was to be before the Council. In the past, Torchy's has filed and withdrawn their application for an alcohol waiver and requested a postponement of

## Intersection Changes

Walking or biking across Lakeshore Blvd. at Riverside can be daunting with right turning cars barely slowing down. It's really not even possible to cross from the south side of Riverside to Lakeshore to access the boardwalk, Cap Metro stops, or nearby restaurants. As part of the East Riverside Corridor study, improvements were recommended for this intersection to create a fully signalized intersection with pedestrian crossings for Riverside, and elimination of both right-hand turn slip lanes.

At the May 19th Council Meeting, a contract was awarded for this project. Construction is expected to begin in late July or early August and is expected to take 4 to 6 months.

the hearing. On May 19th, just hours before its waiver request was to be heard, Torchy's Tacos again withdrew their request after having requested another postponement only days before. While nearby businesses, C-Boys and Magnolia Cafe have been grandfathered from the current ordinance, Torchy's would require the waiver.

The waiver would have allowed the restaurant to sell alcohol at its South Congress Avenue location by granting an exemption from a city ordinance that prohibits businesses from selling alcohol less than 300 feet from a public school. Torchy's needed the variance due to the proximity of Fulmore Middle School across the street.

Thus, with this second withdrawal of the application, Torchy's is presently not able to sell alcohol at their South Congress location.

Torchy's had plans for a full bar at this location even before construction began. They were aware that city regulations do not allow for that. SRCC, AISD and the Bouldin Creek Neighborhood Association were opposed to the requested variance, as were Austin Interfaith and other local groups concerned about the welfare of students at Fulmore.

In 2014, before construction began on the restaurant, the AISD School Board already opposed the waiver, as did Austin Interfaith. SRCC took quick action and voted, in the presence of the Torchy's representatives, to support AISD in opposition of the waiver. The AISD School Board has maintained a policy opposing waivers to the existing ordinance.

At Council on May 19th, several Council Members expressed frustration that this matter keeps popping up, then disappearing without any decisive action being taken. Mayor Pro Tem Tovo and other council members

expressed a desire to change the procedures governing waivers of this nature so that applicants may not simply file, withdraw, and re-file indefinitely. Council has passed a resolution asking city staff to draft a revision to the ordinance that would impose limits on how often the same applicant can apply for a waiver. Stay tuned to see what Torchy's next move will be.

#### CodeNEXT

CodeNEXT is the process of aligning Austin's land use standards and regulations (the Land Development Code, or LDC) with "Imagine Austin," the city's comprehensive plan. CodeNext progressed through several phases during 2013 and 2014:

Listening and Understanding:
—"Listening to the
Community Report" and
"Community Character
Manual"

—Diagnosis: "Land Development Code Diagnosis"

The City of Austin's CodeNEXT team, which includes staff from multiple departments and consultants is busy drafting and refining code elements. Virtually the entire LDC will be re-written or revised, including chapters relating to requirements and procedures, zoning, subdivision, site plan, transportation, drainage, environment, and others. The draft code will be released for public review and comment in January 2017. After an extensive review and comment period, the draft code will be revised in accordance with the feedback received, and delivered for City Council potential adoption. Once the code is adopted, the city will adopt a new Zoning Map to implement the zoning elements of the code.

During 2016, while the CodeNEXT team is drafting and reviewing code, the project team will issue and organize community

- conversations and feedback on some of the most challenging and important topics that the code will address:
- •Natural and Built Environment
- Household Affordability
- Mobility
- •Fiscal Health

This is being accomplished through four "Code Prescription" papers. These Code Prescriptions represent a preview of the specific direction being taken in the new code as well as "conversation starters" to gather community feedback on whether these Prescriptions accurately reflect community values expressed in Imagine Austin. While the Code Prescription papers will not be revised based on feedback received, the feedback will be used to shape the new code. Feedback can be provided in several ways:

- —Through your participation in the work of the Council appointed Code Advisory Group
- —By providing feedback directly at SpeakUp Austin —By joining a CodeWalk or a Reddit/AMA (Ask Me Anything)

## Travis Heights Elementary Fundraiser and Community Action

Another healthy and fun academic year comes to a close at Travis Heights Elementary School (THES). Our school had two big events at the end of the year that were successful, in part, because of neighborhood participation.

On May 3rd, we held our annual end of year celebration and Camp Champions fundraiser at Guero's Taco Bar. THES 5th graders head off to Camp Champions every year for a 3 day/2 night trip that takes learning out of the school building, and into nature. This is a once in a lifetime experience for many of our students, but difficult for some families to afford. Our event brought together neighbors, friends, prospective families, alums, and current THES Thunderbirds to support our 5th graders in raising funds for their trip. Our neighbors in SRCC helped us raise over \$4,000—double the amount from last year!

May 18th, THES PTA and Austin Interfaith held a Community Action to preserve affordable housing in our attendance zone, ensure the city and school district invests in Parent Support Specialists, Prime Time After School, and ensure alcohol sales are prohibited near schools. The Community Action included the owner of *The Heights* 



apartments on South Congress Avenue. The owner plans to redevelop all the low-income units on the property to build market-rate apartments. A large number of THES students live at *The Heights*, so we asked the owner to commit publicly to ensuring a smooth transition for our families during the

redevelopment, that the project would not permanently displace families, and that families will have comparable transportation to continue attending their current school. The owner answered yes, and said that he would continue to work with us.

We also addressed Torchy's Tacos request for a waiver granting them an exception from a city ordinance that prohibits businesses less than 300 feet from a public school from selling alcohol. Two AISD School Board Trustees, and two City Council members pledge to oppose the variance in person or in writing. Council members and Board Trustees that were in attendance also committed to work with us to support funding for Parent Support Specialists, Primetime After School programs, and restoring funding for the Victory Tutorial Program in the 2016-2017 City of Austin budget. We had over 180 people from the community show up to show support. Yet another example of the incredible people living in SRCC—thank you!

## Lakeshore Blvd. Improvements

The City of Austin Transportation Department recently completed restriping the length of Lakeshore Blvd. Feedback from the community stakeholder meeting in Nov. 2015 was incorporated to help ensure that these improvements addressed the concerns of the neighborhood. Changes include multiple new crosswalks with mid-street pedestrian refuges and a two-way protected cycle track from Pleasant Valley Road to Riverside Drive. In addition, bikes turning south on to the various side streets have refuges where they can safely wait to cross without

being obscured by parked vehicles or blocking other cyclists. Parking areas are clearly delineated and are placed so that there is less danger of collisions between bikes and opening car doors. This beautiful tree-lined street, the boardwalk, and the Hike and Bike trail have been transformed in the last couple of years to a much needed, and well utilized recreational area for nearby residents and their families. These changes will help prevent Lakeshore Blvd. from becoming just another shortcut for traffic and help this area retain its character as a neighborhood park.


