Blunn Creek Nature Preserve

A group of your neighbors, including Marty Christman, Jeff Kessel, Elloa Mathews, Gretchen Otto, Betty Weed, and others have been working on an effort to protect a 9-acre parcel owned by AISD that includes the headwaters of Blunn Creek. Blunn Creek is the stream that runs through the heart of our neighborhood, including Blunn Creek Nature Preserve and Stacy Greenbelt. Supporters for the idea of a park there think this wooded tract (full of mature pecans, cottonwoods, and sycamores) will make a great site for recreation, outdoor education, water quality and flood protection, as well as provide critical space for another link in a watershed-long hike-andbike corridor.

Last fall, we were excited to hear that AISD had offered the tract (located at 3702 Woodward, at the east end of Alpine) for sale, lease, or co-venture. Fortunately, the City of Austin, with support from both the Parks & Recreation and Watershed Protection Departments, entered a strong bid to buy the land and develop it as a park. We have been delighted that the Austin Parks Board, a number of south Austin neighborhoods

(SRCC, Dawson, Galindo, Barton Hills, and Zilker), and several conservation groups (the Hill Country Conservancy, National Wildlife Federation. Texas Conservation Alliance, and Travis Audubon Society), have all filed resolutions in support of the park proposal.

However, the tract's future as a park is still in doubt. The District has yet to vote, and is currently weighing the City's bid against a private offer to develop the tract. Since this is the last major unprotected piece of open space in our neighborhood as well as the source of Blunn Creek, we feel that the stakes are high.

To give this possible park its best chance of becoming a reality, we are strongly urging interested neighbors to contact the District through its board (trustees@austinisd.org), executive assistant (Elaine Hopkins at Elaine. Hopkins@austi nisd.org), and attorney (Ylise Janssen at vlise.janssen@austinis d.org) to express your support for the tract's sale to the City, along with the creation of a park.

Bylaws Committee Status Report

The Bylaws Committee has met monthly since January 2016 and continues to make progress in reviewing the current bylaws. The goal is to update the bylaws to reflect the ways SRCC currently works, clarify confusing sentences, and arrange content in logical order that will achieve a final document that is easier to reference.

The target date for bringing the final wording to a vote is the September 2017 General Membership meeting. To provide plenty of advance notification and allow time to gather input from the membership, the plan and timeline is as follows:

February General Membership meeting: committee presented an outline of amendments March Annual meeting: committee will make available the latest outline of amendments and explain the process for distribution of proposed revision as well as the requirements to be met in order to approve amendments. March-April:

members may review the current bylaws and outlined amendments on website. The committee will take feedback from members and continue making revisions. Discussion of specific bylaws will not be

agenda items for March and April meetings. May General Membership meeting: the full DRAFT of proposed revisions will be posted to website. distributed and discussed at this meeting. This is the key meeting for group discussion of the bylaws revisions. May/July: committee will continue to make revisions based on feedback August: the FINAL document containing the proposed revisions will be posted to website. Notification about bylaws amendments will be included in the newsletter and posted online. Notification will explain the process for voting on amendments, the timeline, and how to access a copy of the revisions. Members will have the option to request a printed copy. Discussion of bylaws will *not* be an agenda item at this meeting. September General Membership meeting: membership will VOTE on final revisions. This will be strictly an up-ordown vote—we cannot make further changes once we have distributed the final version for

Issues Continue with St. Edwards

Sherwood Oaks neighbors enjoyed a respite from unsafe parking, traffic, and commercial buses while St. Edwards University took its Christmas break. However, as construction continued on the Operations Building, neighbors reported problems with dangerous dump truck drivers, and the constant noise related to construction. Concerns were shared at a meeting on campus in November with the Sasaki firm hired by SEU to update the university's Masterplan. With the spring semester, so returns baseball season, so neighbors are reminded to photograph and report visiting sports team buses parked on St. Edwards Dr. Although press coverage of the meetings with SEU's PR person reported that buses are being directed to park on campus, busses are continuing to park on St. Edwards Dr. The person St. Edwards has designated to report incidents to is St. Edwards Chief of Police, Scott Burnotes at scott.burnotes@stedwards.edu (please copy your email to Mr. Burnotes to the Sherwood Oaks/St. Edwards neighborhood liaison, Elloa Mathews, at elloamail@austin.rr.com).

Cars parked too close to intersections: State law specifies a clearance from cross walks of 20 feet, and a cross walk is implied at every single intersection of two roads even if it's not painted. If you are unable to see around a car parked at a corner onto St. Edwards Dr. call 311 and report the dangerous intersection and the license plate of the car parked closer than 20 feet to the intersection. The 311 operator will give you a report number. If you are a pedestrian, also document whether the car bears a St. Edwards parking permit, even if it has expired. Send all numbers to Elloa Mathews at ellomail@austin.rr.com This information is being compiled for the City of Austin to install signage and parking safety devices on St. Edwards Dr.

Future development on St. Edwards Drive:

University had hired Kit Johnson, who was recently employed as the City of Austin Architect. A meeting with Kit Johnson and SRCC representatives is planned. Questions remain what plans for St. Edwards Dr. are in the works that would require a

dedicated staff person who is an architect.

University master plan addressed by Neighborhood Plan Contact Team: Questions arose in the winter at SRCC meetings about how the City of Austin approved the Operations Bldg. in Sherwood Oaks since the neighborhood is currently covered by an adopted Neighborhood Plan (NP). Neighbors discovered that the Sasaki firm also designed the Tulane University Masterplan in New Orleans. That city requires that any private institution (like Tulane or St. Edwards) with a master plan within the city engage in community outreach, and that the master plan be compatible with the surrounding neighborhood plans. In November, our Neighborhood Plan Contact Team voted unanimously to send a request to the City Council for an amendment to require the same type of stakeholder process and compatibility for private institutions in Austin that New Orleans requires in an effort to prevent this type of development from occurring again in the future. CodeNext

At the open house on 2/1/17, a Code "Text" draft/preview release was presented. A high level anatomy of the code is described in a pamphlet titled "Shaping the Austin We Imagine": What it looks like: The code document has been designed to make regulations easy to understand and clear to navigate. A Table of Contents is included in each new section. Graphics and illustrations visually explain regulations, indenting, section breaks, and labeling add clarity. How it's organized: "Relocated under a different number [23], an extensive reorganization of the Land Development Code elevates community priorities, consolidates procedures, and introduces a hybrid zoning code with new form-based [emphasis SRCC] standards."

Of interest to those of us living in the SRCC area are the zoning codes relating "transect and non-transect zones + overlays", and from the pamphlet: "The transect zones reflect the community's vision for implementing the intent of Imagine Austin to strengthen or create walkable spaces, and produces a walkable urban environment of desirable character." These zones range from less urban to more urban:

T3, up to 2 stories; to T4, up to three stories; T5, from 3 to 6 stories; T6, up to 16 stores (T6U), to unlimited stories (T6UC)." Non-transect zones + overlays are described as consolidated and refined, and will continue to be utilized primarily in suburban areas." SF3 is considered as "low to medium density residential: single family detached, duplex" in this zone

While we were not able to tell from the code text draft how SRCC will be affected (pending the mapping tool), it is possible that we will be considered in the last group: non-transect zone plus overlays. If so, the following could apply, again from the pamphlet: Overlay Zones are defined as: "Standards for the overlay zones are intended to ensure that proposed development is compatible with existing and future development within unique parts of the city that have a particular character or open space considerations." Several different types of overlay zones are called out, including Neighborhood Plans. SRCC is in two Neighborhood Plan areas; areas 1-5 and 8 are in the Greater South River City NP, and areas 6-7 are in the East Riverside Oltorf Combined NP.

Recent comments on transect and non-transect zones from a recent

Austin American-Statesman article: "In fixing the system, CodeNEXT takes a Bifurcated approach, essentially dividing the city into two zoning areas: transect and nontransect zones. Non-transect zones are not expected to be controversial, given that they would determine zoning mostly in suburban areas and resemble current zoning. [Emphasis SRCC] It's the transect zones that already are being criticized for opening central Austin neighborhoods to density in the way of apartments, duplexes or other such housing. Those zones, incorporating goals of Imagine Austin, would determine land-use and zoning mostly in central and urban areas of the city."

However, without zoning maps it's impossible to know [emphasis SRCC] how central Austin and other urban neighborhoods will be affected. For example, some will get zoning that allows buildings up to two stories, while other, will get zoning that permits high-rise buildings with zoning allowing an unlimited number of stories. More detail is provided in the draft code Division 20-3C.3 Residential Non-Transect Zones (see the link below). The Mapping Tool, draft

version of which is due for release in April 2017, will clarify which zone/ overlay we fall into.
