We, the undersigned hereby petition for the designation of the residential frontage along Alameda Road (East Side of Street Only) between Mariposa Drive and Rosedale Terrace, as well as along Rosedale Terrace between Alameda Drive to the end of the first property line on Rosedale Terrace for the hour's from 6:00 A.M. to 7:00 P.M. on Monday through Friday as a Residential Permit Parking (RPP) area according to guidelines and procedures established by the Austin Transportation Department. We understand that the residents will have to purchase the parking permits yearly for a fee (this fee will be used to offset the cost of the permits, sign fabrication, installation and enforcement). The fee for each permit is \$15 per permit plus sales tax, up to 4 (four) permits per eligible household. Types of permits include resident decals and visitor hang tags (Visitor hang tags have a max 2 per household).

Note: The Street mentioned above will be considered for RPP designation only if the affirming signatures below represent at least 60% of all the households (residents only) adjacent to the street. ALL PROPERTIES (INCLUDING EACH APARTMENT UNIT/DUPLEX) ON THE STREET MUST BE LISTED ON THE PETITION. Only one signature from each household will be considered. Resident vehicle license plate numbers are collected to determine eligibility based on non resident/commuter vehicles parked within petition area.
