This November's mid-term election includes many important races for Austin voters. Statewide races include senator, governor, and lt. governor. Our neighborhood will be voting for city council members for Districts 3 and 9, as well as mayor. There are also seven city bonds and four other propositions on the ballot. Please be sure to exercise your rights and make your voice heard!

## Voter ID

Voters are required to present a valid ID in order to vote. Here is a list of the acceptable forms of photo ID:

- Texas Driver License issued by the Texas Department of Public Safety (DPS)
  - Texas Election Identification Certificate issued by DPS
    - Texas Personal Identification Card issued by DPS
      - Texas Handgun License issued by DPS
- United States Military Identification Card containing the person's photograph
  - United States Citizenship Certificate containing the person's photograph
    - United States Passport (book or card)

#### **THES Tamalada Turns 25**

Growing up, around the holidays someone's kitchen (my mom's, my aunt Bony's or my aunt Sylvia's) was taken over by a large crowd of aunts, uncles, cousins, and friends for our Holiday *Tamalada*. To this day we get together every year. At a *tamalada* everyone has a job. Cousin Nito was in charge of *amazar la masa*, or kneading the corn *masa*. He now shares this job with his son who has bigger muscles than him these days (muscles or machines are very helpful for this step, when a large quantity of masa is involved)! My mom is in charge of making the *guisados*, the pork, chicken, and pepper fillings. These days, she makes vegan *guisados*, and vegan masas, as well. The rest of us make an assembly line around the table, and spill out in to the rest of the kitchen and dining room. We take the soaked corn husks and some of us spread the masa, and others add a portion of guisado to the masa fold the tamal (yes tamal, not tamale) and prepare it for steaming.

When I came to Travis Heights Elementary twelve years ago, I felt right at home when I found out that my Thunderbird familia has a Tamalada tradition of their own. I still remember my first Tamalada... retired teacher friends Chris Contreras and Carlos Gonzales handing out bandanas for our hair...my comadre Ysabel Peña talking my ear off...the school cafeteria filled with parents; some experienced, some novices...big containers of masa, and real spoons (not plastic cafeteria spoons). The familiar scents of guisados fill the air. Year after year, being a part of this tradition, which turns a quarter of a century this year, has been something very special.

The Travis Heights Elementary *Tamalada* started in 1993 as a way to draw parents in. A few years later, the *Tamalada* became part of the Travis Heights PTA fundraiser "Winterfest." By the time I came to Travis Heights, there were two different events: a Tamalada, and a Tamalada festival. The *Tamalada* happened on a weeknight, usually Wednesday, where the Travis Heights community would get together to make tamales with ingredients donated by area restaurants and grocery stores. The *Tamalada* Festival was on the following Saturday and these tamales would be sold/picked up at this festival. A few years ago we changed the name of the Saturday event to "Cultural Festival." (I personally would not object if we changed the name back to Winterfest.)

The Cultural Festival is a fun school community event that includes performances, tables celebrating a wide variety of cultures, and a *mercado*. The PTA is always looking for parents, neighbors, and teachers to create the cultural tables for the festival. At these tables, members of our community can showcase something about their culture, their heritage, their countries of origin (or that of their parents/grandparents), and so on. Both events have evolved throughout the years, as have our school and our community, but the core of the tradition is still here.

Our Tamalada this year will be held on Wednesday, December 5th, in the afternoon, and the Cultural Festival will be on Saturday, December 8th, in the morning. ## **Fulmore Middle School Renaming**

Earlier this year, the Austin ISD Board of Trustees voted to begin the process of renaming five schools whose names had ties to the Confederacy, and Fulmore Middle School was one of those schools. Fulmore is named after Zachary Taylor Fulmore, a judge who helped create a public school system in Austin, and served on the school board for 18 years. He was also a private in the Confederate Army. The district accepted name ideas from the public, and then created a School Renaming Task Force with committees at each affected school. The committees considered all suggested names, voted, and made recommendations to the board.



The new names had to follow criteria set by the district, and could include naming the school after a person, the school's curriculum, or after a geographic feature. The top three choices submitted to the board by the Fulmore naming committee are:

- Sarah Beth Lively (a teacher and volunteer at Fulmore for 40 years)
- South Congress (the street where the school is located)
- Moon Tower (iconic lights throughout Austin; one is located near the school at Leland and Eastside)

The school board is scheduled to vote on the finalists on October 29, after this newsletter has been printed. Please check www.austinisd.org for information on the final vote.



#### **Proposition J**

You may recall that early last October, SRCC wrote a letter to Mayor Adler, Mayor Pro Tem Tovo, and Council members to request time extensions for the then Current Draft 2 of CodeNext, and the Proposed Draft 3. We requested a time extension of at least 6 months in order to have time for "adequate feedback, answering of questions, and revisions." Later that month, we wrote to Greg Guernsey, Director of the Planning and Zoning Department about the second draft. A detailed "position paper" was attached, touching on many issues that we felt would be harmful to our neighborhood:

- Preservation/Demolition
- Flooding and Environmental
- Affordability
- Compatibility: Bars (proposed zoning restrictions for alcohol far too permissive), Stealth Dorms and occupancy limits, drive-through uses, and compatibility with existing residential (asking to keep existing McMansion Residential Design standards intact)
- Public access to decision making.

Then, in May 2018, SRCC wrote again to the Austin City Council, as above, regarding our position on CodeNEXT draft 3. To briefly recap, (all these letters are available on the SRCC website):

- Draft 3, a complete rewrite, but not a revision, is "rife with errors, omissions, and contradictions."
- Consultants have confirmed that CodeNEXT does NOT provide for affordable housing, which has been a rationale for the project from the beginning.
- Makeup of Planning Commission resulting in an imbalance of development interests has not been addressed and is now the subject of litigation.
   Contrary to popular belief, CodeNEXT is not dead.

Special interests will, if not stopped, attempt to repackage the same pro-developer policies and force them onto our community again. However, we do have a choice: In November, vote for Proposition J. This will call for a waiting period and a public vote, before the next "CodeNEXT."

## Austin Historic Landmark Commission Delays St. Edwards Demolition Permit

On July 23 the Austin Historic Landmark Commission heard a request from St. Edwards University to demolish Andre Hall near the campus' historic Main Building. Andre Hall is a few feet outside the National Historic Register District which was created in 1979.

Angela Reed and Elloa Mathews presented SRCC's request to the commission that the Andre Hall demolition permit be withheld until the university releases its Master Plan which was approved last year. The university asked for neighborhood input into changes proposed on campus that would impact life in Sherwood Oaks north of campus. Since the Master Plan was approved last year, but not released to the public, the type of structure proposed to replace Andre Hall has not been disclosed. SRCC requested that the commission withhold the demolition permit until St. Edward's releases the Master Plan.


During the hearing, commissioners asked St. Edward's when the Master Plan would be released, and whether Andre Hall had any historical significance. The St. Edward's representatives stated that the building did not have historical significance despite Brother Andre Bessette being the first Holy Cross Brother to be canonized as a saint by the Catholic Church. His Wikipedia page describes Andre Hall being built in his honor.

While the St. Edwards representative informed the commission that none of the university's research on Andre Hall had revealed any historical significance, Commissioner Beth Valenzuela did a quick search in the Austin American-Statesman archives and discovered that the firm that designed Andre Hall, Julian and White of San Antonio, had also designed an early kitchen and dining hall, as well as the science building and Fleck Hall, which has been restored. The Statesman archive also revealed mentions of the design firm's work in the national historic register, which could establish a need to save Andre Hall instead of demolish it. Commissioner Emily Reed said, "It's a future possibility that the (historic) district could be expanded." When the St. Edward's representatives and city staff said they were unaware of this information, the commission suggested that St. Edwards go back and complete their research and postponed the release of the demolition permit.

As far as releasing the Master Plan, there was a bit of subterfuge by St. Edward's. The new architect reported that even though St. Edward's had approved the Master Plan update last year, they would go live with it on their website on Aug. 1. Architect Kit Johnson also reported to the commission that the university was under no obligation to do so. However, as of the publication of this newsletter, the Master Plan is now posted on St. Edward's website at https://stedwards.app.box.com/v/SEUMasterPlanExecSummary.

As part of the requirements of the National Historic Register District, the property owners have an obligation to maintain the views of the buildings in the district to the public. Elloa Mathews shared photos of the new Operations Building on St. Edwards Dr. with the commission as evidence that the new two story sheet metal building was blocking neighbor's views of the historic Main Building. One commissioner asked Mr. Johnson if he could "move the ugly metal building"? Mr. Johnson's response was that the view was not as bad as the photos revealed.

At the follow up hearing in August, the demolition permit was released unanimously on consent, upon completion of documentation of the building.
