## René Barrera 1958–2019

We regret to share that René Barrera, manager of the Austin parks system's nature preserves, former SRCC President, environmental activist, chimney sweep, Uncle Sam in the local July 4<sup>th</sup> parade, great friend, and many more things, passed away April 15<sup>th</sup>. We cannot overstate the impact he had on Austin's natural environment, and especially on our own neighborhood parks. Here are a few memories our neighbors have shared about René:

"My first visit to Blunn Creek Nature Preserve was in September of 2010, to help René lead a volunteer group from Dell. At that time, I had been a park volunteer for several years but had never seen a preserve in as bad shape as Blunn Creek. Literally hundreds of thousands of ligustrum, chinaberries, nandinas, and others had destroyed native species, habitats, and their ecosystems. With René's guidance, we embarked on an ambitious (perhaps quixotic) project to remove the invasive plants, and restore Blunn Creek with native Texas plants. René tirelessly corralled the involvement of City departments, contractors, SRCC, Blunn Creek Partnership, and countless volunteer groups. René's work, still in progress, stands proudly today. Blunn Creek's grasslands, springs, birds, and wildlife are coming back strong as a living memorial to his devotion."

## Fulmore Middle School Name Change and Mural/Crosswalks Project

It's official! The AISD board of trustees voted to change the name of Fulmore Middle School to ***Sarah Beth Lively Middle School***, and the new name will be in place for the upcoming school year this August. The new name is in honor of former teacher, Sarah Beth Lively, who taught at Fulmore for 25 years and then volunteered at the school for another 22 years. The school mascot will remain the Falcons, and new logos have been created. Over the summer, signs around the school will be replaced or repainted.

This fall, Lively Middle School students will partner with the City of Austin and SRCC on a project to create a mural along the fence in front of the school, as well as specially painted crosswalks around the school which will both highlight the name change, as well as improve safety. Recently, in May of 2019, a student was hit while crossing Brackenridge during dismissal. We hope that by painting many of the crosswalks that lead to and away from the school with the new logos and student

-created artwork, it will reduce the likelihood that a student will be hit by a car in the future. Students will also be doing PSAs about the crosswalks and getting support from the community for the designs. When students return to campus in August, they will pick up the project started by the Student Council in Spring 2019, through various student organizations and classes that focus on the outdoor spaces around the campus.

Our middle school has a rich history going back to 1886, and with the name change to Lively Middle School this year, students had the idea to create a mural along the fence in front of the school that will chronicle the development of the site from a Ward School in 1886, to the school you see today—Lively Middle School. The students hope to create an iconic City of Austin style mural where people stop to take photos, and learn a little about the history of the school as represented by student and community art. Students hope to collaborate with other artists in our community who want to help commemorate our unique heritage through this project.

Lively Middle School uses project and problem-based learning methods, which means that students are presented with a problem or a design challenge through their course or club activity, design solutions, make presentations to the community stakeholders, and then use that feedback to strengthen the design and implement the solution. The projects are facilitated by adults, but are conceptualized and implemented by students as requirements of their affiliation with clubs and organizations, or enrollment in the outdoor learning program. Students will be expected to survey neighbors, present ideas to groups of stakeholders, use engineering design thinking principles and collaborate with volunteers to make ideas come to action. Please check future SRCC agendas for a presentation by the students, possibly happening in August or September.

## Neighborhood Watch Update

### **We are still in need of volunteers for the Neighborhood Watch Patrols.**

Our goal has been and is to get all of the 8 areas of SRCC covered by patrols at some point, for walking, bicycling and/or driving for periods of a minimum of 30 minutes to an hour. There are different viewpoints on what type of patrol is most effective, such as the benefit of patrolling the area around your street so that something or someone out of place is easier to spot. Paramount in this is the goal of having all of the areas patrolled at one time or another, and in particular, at times and in areas where the most criminal activity is occurring, and recognizing that many (if not most) participants are typically not able to patrol late into the night. New magnetic patrol signs for vehicles are available to volunteers at locations in Travis Heights and we are looking for ways to make them available in other neighborhoods of the SRCC. Any ideas on where to make the signs available will be appreciated!

### **Neighborhood Watch Patrol works!**

Residential and vehicle burglaries have declined rapidly in neighborhoods where patrols are active. The SRCC Neighborhood Watch Patrol Program is an extension of the classic Neighborhood Watch concept, but provides a more proactive element to enhance the ability of a neighborhood to reduce criminal activity. It involves neighborhood volunteers patrolling in clearly-marked vehicles looking for signs of criminal activity, suspicious persons or Vehicles, and providing a visible presence in a neighborhood to deter criminal activity before it occurs. Criminals attempting to operate in a neighborhood patrolled by volunteers become more at risk of detection.

Recent crimes reported in the SRCC neighborhood list-serv such as Nextdoor Neighborhood Travis Heights in the past month in the SRCC Neighborhood Areas include: armed robbery, car burglaries, mail box break-ins, trespassing, front porch package thefts, and indecent exposure.

### **Neighborhood Watch Patrols are non-confrontational.**

**Volunteers must understand and agree that no volunteer is to confront a suspicious person or approach a suspicious vehicle.**

Instead, they are to call 911 and report their concerns to the Austin Police Department. The Austin Police Department representatives for our area have emphasized that we should not be shy or hesitant about reporting something by calling 911, even if it turns out to be nothing, as it is better to be

safe than sorry. Together, being vigilant about what we observe, it is equally important to make it difficult for criminals to operate in our neighborhood:

- Lock doors and windows of homes and vehicles; do not leave valuables in vehicles or where they otherwise can easily be seen
- Turn porch and other outside lights on at night, particularly in dark or secluded area
- Keep bushes and shrubbery trimmed around windows and doors close to the house
- If possible, install security systems and security lights.

## Son of CodeNEXT: LDC Revision Restart

The Land Development Code (LDC) revision process formerly known as CodeNEXT has been restarted by city council and the city manager. On May 2, the city council adopted a policy direction for the city manager which, in most cases, directs city staff to make changes to the LDC that would result in more density than CodeNEXT proposed. The policy direction calls for more new housing units by reducing compatibility standards, reducing site development standards, reducing parking requirements, and creating transition zones next to all corridors in which single-family housing would not be allowed.

This new plan is on a fast track to be brought to council this fall with minimal time for public input. Neighbors in SRCC are concerned about the possible impacts to folks who live near South Congress,

Oltorf, and Riverside, all of which are corridors with transition zones. Other concerns include the loss of impervious cover and heritage trees and resulting exacerbation of flooding danger, the loss of historic homes and neighborhood character through incentivizing demolition, and the decrease of affordable housing by demolishing older, affordable homes and complexes to make way for newer “market rate” luxury buildings.

SRCC has created a new ad-hoc committee to study the proposals, track the code revisions, and communicate our feedback to city council and staff. ## Memories of René Barrera

"I remember René helping guide 2nd grade field trips from Travis Heights Elementary to the Blunn Creek Preserve. We started creekside near the school with the all-important plant identification lesson of poison ivy. He added willows and wildflowers to teach that good and bad in life are mixed together, and we can learn to tell them apart. Then we trooped down Eastside to the preserve. René would lead them to an ammonite mold in the creekbed, mollusk shells in the exposed limestone, and native springs. He'd recount the legend of Mr. Blunn's demise, and show more plants, including the prickly pear and its risks. The kids were especially impressed, and sometimes anxious, when standing on the ancient volcano. René would assure them that it would not blow up anytime soon. For many kids, this was their first exposure to nature outside concrete and cut grass. The lessons he gave them, and us, were as much about the stewardship within us as the environment around us."

"René was dedicated to the Blunn Creek Preserve and through that, he and Brother Daniel Lynch (a beloved professor and ecologist at St. Edwards) became close friends. Because of his love and dedication to Br. Daniel, René extended open arms to all of us at St. Edward's. He spent endless hours helping educate our students about the benefits of the Preserve and the importance of restoring it to some semblance of its original condition. Above all, René was a kind person who brought education and happiness to so many people. We have lost a great friend but we have gained so much because of René."

"In 1999, Home Depot proposed to buy part of Ascension Cemetery from the Holy Cross Brothers to develop a large store and two fast-food restaurants at the corner of Woodward and I-35. Our neighborhood was up in arms. There was immediate opposition, and René joined the SRCC leadership to try to stop the sale and construction. Unfortunately, City Council made it clear that they would not oppose the project, so we entered into negotiations with Home Depot. One of our greatest concerns was the increase in dirty runoff and erosion from such a development. After months of negotiation and with René's invaluable knowledge of the creek and wilderness area, Home Depot agreed to cede about one-third of the land to the city (at the time valued at over \$2 million) as a conservation easement. We were saved from having the entire area paved-over for a couple of fast food vendors."

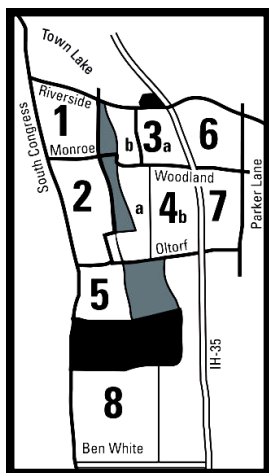
